# PRESIDENT'S MESSAGE

On behalf of the Board thank you for the opportunity to present the 2020-2021 annual report to Pegasus Members.

As it was last year, this year has been impacted by the COVID-19 pandemic causing long periods of suspension of programs, disruption to operations, difficulties due to COVID-19 limitations for site access and disruption to the acquisition and training of horses.

Once again staff and volunteers have risen to the occasion throughout the pandemic ensuring Pegasus operations continued a limited scale, caring for and maintaining a fitness program for our wonderful team of horses and maintaining the facility.

The core business of Pegasus is to support the community by delivering programs and services to ensure sustainability to strengthen our strategic intent of developing abilities for people with a disability. COVID-19 has severely impacted on our ability to deliver programs throughout the year. Between July and December 2020 116 classes were cancelled due to COVID-19 restrictions severely impacting on participants.

Despite this, I am pleased to report financially the year has quite remarkedly been successful with Pegasus delivering an operating profit of \$109,096, a turnaround of \$358,921 on the previous year. Pegasus has \$931,783 in cash and investments an increase of \$335,370 on the previous year. The operating profit was achieved with the addition of \$115,000 from the Federal Governments job seeker program which compensated for the loss of revenue in other areas.

This result is a significant turnaround on the results of the past two years; however, the organisation cannot be complacent and must continue to implement and be aligned with the 'Road to Recovery" initiatives and strategies adopted last year. Details of the financials are contained within this Annual Report and will be explained in detail by the treasurer at the Annual General Meeting.

The key points of the Road to Recovery are covered below in relation to the outcomes for this financial vear.

**Staffing:** It is important that at a minimum that the current ratio of staff costs to revenue is maintained in future to support sustainable outcomes for the organisation. Staffing costs decreased by \$120,324 for the year compared to the previous financial year.

Land Management & Usage – There has been a focus on land improvement and usage, including the introduction of a farm working group, a managed paddock maintenance program and the introduction of agistment of outside horses. Agistment has generated \$29,434 in new and additional revenue. In addition, the Snow Foundation have pledged \$35,000 towards land management. Due to COVID-19 restrictions the plan to introduce paid riding lessons on the riders' own horse has been delayed.

**Herd** - Following a comprehensive review of the Pegasus herd, an acquisition, training, maintenance, and disposal plan was adopted including identifying output capacity to achieve growth to deliver programs to more than 100 participants. Again COVID-19 has impacted on acquisitions and training however a net gain of three working horses has been achieved.

**Participants -** The Board recognizes that participant numbers are closely aligned to herd capabilities, coaches, and volunteers It is pleasing that participant numbers have increased overall, in March 2020 Pegasus had 55 active participants which decreased to 33 during the pandemic and increased to 67 prior to the latest lockdown. We still have away to go to achieve our Road to Recovery Target of one hundred participants

**Fundraising** – COVID-19 did not impact on fund raising as much as expected. Overall fundraising raised \$382,648 an increase of \$8,938 on the previous year. The introduction of the Futures Fund which evolved into the 104.7 Pony Up for Pegasus fund raiser raised \$35,000. This offset the loss of approximately \$18,000 due to the cancellation of the Pegasus open day. If in a normal COVID-19 free year Pegasus can maintain its traditional fund-raising events and further develop the Futures Fund, the Road to Recovery target of an additional \$50,000 per annum from fund raising will be achieved.

Government Funding – Pegasus has not been able to engage with the relevant ACT Government Minister during the pandemic. It is important to continue to engage with the ACT Government. Pegasus must demonstrate its relevance and value to the community to remain relevant and be able to quantify the difficulties for the organization since the cessation of Government Funding and the introduction of the National Disability Insurance Scheme.

We must ensure that the structure and operations of Pegasus is capable of sustaining Pegasus for the future. It is critical that the structure of Pegasus supports the abilities and capabilities of staff and volunteers to generate sufficient revenue whilst maintaining costs to operate profitably whilst developing abilities for people with a disability through our riding for the disabled programs.

In addition to the effect on program delivery and participant numbers, disengagement with the community and community groups has been the significant collateral damage of the COVID-19 pandemic. It is important that Pegasus rebuild community engagement and participation once we are free of COVID-19 restrictions. This will require input from within the Pegasus family culminating in a planned awareness and marketing program.

# EXECUTIVE GENERAL MANAGER

As we come out of the ACTs first self-imposed lock down I take this opportunity to look back at the past financial year and think how lucky we have been compared to other states and territories.

It wasn't all perfect however, after the first nationwide lockdown Pegasus was still adapting to the new normal. Term three 2020 we were still not able see the return of all our participants due to social distancing restrictions, however for those who were able to return it brought so much happiness back. Though it wasn't long into term four that we were back into the full swing of programs, and as the weeks went by more participants were able to return as restrictions eased. By the middle of term four everyone was back, and we were well and truly galloping into the Christmas season.

But even with restrictions so much still happened before Christmas, kicking off as we celebrated the horse's birthday on 1 August. This year was a quite event as we could not invite our supporters, but this special occasion did not pass by unnoticed. The horses' birthday week was celebrated by all with games and party food, not to mention copious amounts of carrots for the horses. Thank you to everyone who helped share our celebrations, and for all the amazing birthday cards.

The first event of the year was the Pegasus Charity Golf Day held on 24 September and supported once again by 2 Constitution Avenue, this event was one of the first big events back locally and the first fundraising event hosted by Pegasus in 2020. The weather was kind and with strict COVID-19 procedures in place everyone was able to have a safe day while raising over \$24,000 for Pegasus.

This was quickly followed up by the Corkhill Bros. Pegasus Charity Race Day 2020, moving from our traditional winter date to the spring carnival calendar, the new date proved to be a great success. A day of racing, auctions and raffles saw \$27.000 raised.

March 2021 was the launch of the Strathnairn Charity House, this amazing once in a lifetime opportunity will see a dedicated house build go to auction with funds being distributed amongst three local charities. Pegasus, Karinya House and Canberra City Care Charnwood. Sadly COVID has pushed the construction of the house back with the auction

occurring in 2022.

And who could forget the amazing Pony Up for Pegasus event that ran over two weeks with the support of Ned and Josh on 104.7s breakfast show. Two weeks of on air promotion and fundraising, culminating with the boys riding live on air on the final day; their challenge, not to stop until \$30,000 was raised. **And they did it! Huge effort boys.** 

All events were a massive success after the uncertainty of COVID-19 throughout the year and the cancellation of our Open Day for a second year. Thank you to all our sponsors and supporters who joined us during these events helping to ensure Pegasus can continue to deliver our unique services to participants in our Pegasus community.

But it didn't end there, before we knew it, Christmas was fast approaching as was our end of year Christmas party and Volunteer Appreciation evening. This year we welcomed a new supporter of Pegasus, Parbery Consulting, who generously funded our event. After the year that was, we wanted to make sure everyone was able to let their hair down.

The Christmas party is only half the evening, we also take this opportunity to say thank you to the many volunteers who make Pegasus possible, including our awards for service provided. This year also marked a very special milestone for our one and only Sheila King. Sheila completed her 20 years volunteering with Pegasus and is still working every week ensuring our tack and tack room are up to the highest standards. Thank you, Sheila, and to all our volunteers who generously give so much of their time.

This is only a very small number of the wonderful fundraising activities that occurred throughout the year, and I encourage you to read more about everything that happened in the fundraising report.



The year also saw some great grant funding opportunities, this includes The Snow Foundation who are providing funds to help improve and maintain our pastures and create a more sustainable farm for feed and drought hardiness. The Lord Mayors Foundation provided funding once again to Pegasus to help fund the purchase of new ponies for our herd and continue with training and assessment for our coaches, and ACT Sport and Recreation for providing funding to upgrade our small indoor arena into an area better suited to wheelchairs and other mobility aids, and as a dedicated space for our Horseability programs.

2021 kick off in January with the return of summer school holiday programs after having to cancel the previous year due to the bushfire haze. Our school holiday programs are a great way to introduce new participants to Pegasus or for those who cannot attend during school term. These programs lead into the start of term one, the first weeks are a mix of excitement and nerves not only for our participants, but our volunteers and coaches. We all love what we do and can't wait to get classes underway each year.

Term one and two also had an increase in numbers of participants, working closely with Kim and Janelle we were able to identify areas where numbers could be increased. Our unmounted program also went through a rebrand and has become known as Horseability, and we are all excited to see this program grow over the next 12 months. More details can be read in our program and volunteer report.

2020 also brought some changes within the organisation, with the previous two years running at a loss the board and management had to make some very tough decisions to help ensure the longevity of Pegasus. These decisions, though difficult, have helped bring Pegasus back to a positive financial position within the same financial year.

This was also bolstered by the introduction of agistment within the Pegasus grounds and turning under utilised land into a new income stream that will directly support Pegasus.

It is also important to acknowledge what affect the Government JobKeeper subsidy had for Pegasus in returning such a positive result, without this the figures would have been much closer to break even and reflect a more realistic picture of where Pegasus stands. It also helps to highlight the reality of how far Government support can go, and why it is so important we do not give up on building those relationships with local Government.

Unfortunately, we still struggle to build strong relationships within local government, with several meetings being cancelled due to COVID-19 and the disruption of a local election the opportunity to put forward the importance of government support for Pegasus has proven to be difficult. However, the board and I will continue to put Pegasus in front of our local Ministers throughout 2022.

2022 will also see our new Strategic Plan being developed, with RDA Australia recently releasing their plan, Pegasus will be developing our new plan in line with the national direction and with a strong focus on reconnecting with government, program development to better handle the growing need of our services and to ensure the financial sustainability of the organisation as a whole.

Overall, even with all the challenges presented during the 2020/21 financial year, I am pleased to present an organisation that now has a positive future ahead. It is never easy working in a charity, and it is only through the amazing commitment and strength of the Pegasus community that we continue today. I would like to take this opportunity to say thank you to every person who helped make this happen, from my admin team, Anna, Chai, Jannelle and Kim, all the coaches, volunteers, and families; Pegasus truly is a community organisation.

Thank you also to the Pegasus board for their continued support during what was a unique and at times difficult year. A special thank you to Peter Stubbs and Tony Curtis who after many years have decided to step down, your support and guidance during my first years in the charity sector has truly been of value and I wish you both the very best in your future endeavors.

showing great promise for the future.

Volunteer numbers were poor at the start of the 2020 – 2021 Financial Year, and this proved to be quite problematic for us, at times with all available hands-on deck to help in classes. However, this is starting to turn to corner, with many more applications coming in and lots of training sessions being run. Of course, life in general is not always smooth sailing and we have had some difficult times. Covid-19 from early 2020 did have a financial impact on Pegasus and sadly saw some position redundancies. # Fundraising report

Community is what drives fundraising at Pegasus. This is reflected in the number of individuals, businesses, volunteers, and staff, who worked together to create successful fundraising campaigns and events even in the toughest times. For Pegasus, fundraising in the 20-21 financial year did reflect the ongoing impact of closing the gates for a short period. 



# Our board



#### President - Peter Stubbs

Peter has been on the Board of Pegasus for six years serving as President from 2015 to 2018. He served as Vice President in 2018/19 and returned as President for the 2019/20 Financial Year.

Following a review early in 2020 the Pegasus Board made a number of significant strategic decisions in order to secure the future of Pegasus including the objective of delivering a financial result of close to breakeven for the 2021/22 financial year. These decisions included containment of costs including the ratio of wages relative to revenue, promoting revenue growth through fund raising initiatives and program expansion and to increase herd size and capabilities in order to increase participant numbers.

With the acceptance of Members and support of the Board and

Management it is Peter's intention to ensure that these strategic decisions are implemented in order to deliver the required outcomes to secure the future of Pegasus. Outside of Board responsibilities it is also Peters intention to continue as a volunteer assisting mainly in the area of facilities grounds and pasture maintenance.

Peter is retired having held senior management roles and Board experience throughout his career, he has a Master of Management and a Certificate in Accounting both from the Australian National University.



#### Vice President - Wendy Gould

Wendy is a HR Director with Raytheon Australia, leading the design and delivery of Raytheon Australia's learning and development framework, talent acquisition and talent management programs, including Leadership and Graduate Development Programs.
