#### PRESIDENT'S MESSAGE

#### **Wendy Gould**



I'm pleased to present this year's Annual Report of Pegasus' 48<sup>th</sup> year of operation.

This time last year, we launched our 2022 Strategy which introduced five pillars aimed at focussing our efforts out to 2027. The pillars are Engage, Partner, Grow, Celebrate and Govern so, I am equally pleased to report that the Strategy has, in fact, provided the focus needed to ensure Pegasus continues to be financially sound, sustainable and well governed.

This year, our programs and engagements touched the lives of over 100 people living with disability and, once again, this would not have been possible without the generous support of the Pegasus community, staff, volunteers, donors, and sponsors alike. As a direct result of efforts to expand our reach through engagement and build meaningful partnerships, we benefitted from a variety of fundraising activities throughout the year which boosted our financial position considerably. Details of these activities are provided in our financial statements, however, to summarise, we received in total \$557,453 in donor support across the year and secured a further \$126,741 through the sale of the Strathnairne charity house, which will be realised in the next FY.

Furthermore, to ensure program delivery is sustained into the future, we received a further \$225,000 over three years, in the form of a grant from ACT Sport & Recreation which has enabled us to grow our coaching capability so, I am delighted to welcome Louise, Rose, Emily, and Abbey who are all progressing their coaching qualifications with much enthusiasm. This generous grant acknowledges the important work Pegasus does in the wider ACT community and will help us to build on our existing programs.

Everyone knows our horses are the centre-piece of Pegasus', supporting participants throughout the year and giving so much of themselves and it is always a sad time when we have to say goodbye to them. Sadly, we

farewelled Jacko, and Emmie who retired back to her home during the year and so I would like to take this opportunity to acknowledge the enormous contribution they each made to our programs in their own special way and the place they filled in so many hearts. We also welcomed newcomers to the herd, Flicker and Bella, who are doing well and already in programs, helping ensure our programs continue with minimal disruption.

The Pegasus Board of Directors work hard to support and guide the future direction of Pegasus and it has been my absolute pleasure to work alongside the CEO, Matt Watson, and our Board of Directors throughout the year. We are on track with our Strategy and are committed to ensuring Pegasus continues to grow and remain financially strong, securing its future in the community.

Importantly, I would like to recognise and thank the efforts of our small team who punch well above their weight. The willingness of the team to go above and beyond almost every day is not lost on me and I'm sure you will join me in thanking them for their hard work and dedication. To our donors, sponsors and volunteers, I also extend my sincere gratitude, for they too are important to our continued operation. It really is a team effort.

Thank you to everyone in the Pegasus family for what you do.

#### FROM THE CEO

#### **Matthew Watson**



As I completed my first five years at Pegasus in October 2022, I am still amazed at the miracles seen almost every day and the dedication shown by our team of coaches, volunteers, and everyone else behind the scenes making it happen; and therefore, it gives me great pleasure to share with you the 2023 annual report.

With the release of the new Pegasus Strategy in 2022, the board and I have been working to incorporate the five pillars into all that we do. By ensuring we include the five pillars of Engage, Partner, Grow, Celebrate, and Govern into our planning we believe it will ensure the future of the organisation and set us up for the years ahead.

In recent times we have been working hard to *Engage* more within the Canberra community, this has seen the Pegasus name and brand becoming better known throughout the younger generations while still being relevant to our long-term partners. This in turn has seen community donations grow over the previous year and our volunteer base also grow.

After hosting Deputy Chief Minister, Yevette Berry, to meet some of our families and see a class in action, we were pleased to announce ACT Sport and Recreation coming on board with a three-year funding deal to help *Grow* our organisation and in turn provide more services to those living with disability in Canberra. This support allows us to fund training and resources for new coaches and investigate new opportunities our services can benefit. This saw some ambitious targets set and we are well on our way to making those targets a reality. Congratulations to Louise, Rose, Abbey, and Emily for starting their coach training journey as part of this funding, and thank you to ACT Sport and Recreation for your support making this possible.

Another wonderful achievement was to see the return of our Open Day, after being cancelled two weeks out in 2020, it was a joy to see the Canberra community back out in numbers and showing their support for Pegasus. This combined with our annual Golf Day and Race Day and the growing Pony Up for Pegasus event has seen our calendar filing back up with events for all ages and interests. These events are an important part of our community and fundraising activities and would not be possible without the support of all involved.

In April we had the opportunity to *Celebrate* our supporters old and new, individuals and businesses who appreciate the work Pegasus does and understand the need for their support to continue delivering our unique horse facilitated services. With food and drink being served in the original indoor arena and throughout the sensory gardens it was a

great opportunity for our supporters to meet with our coaches, board members, and the team, while also hearing from one of our families why they love Pegasus so much and what it means for them to attend.

We didn't see any big infrastructure projects for the year, but it is important to recognise the large amount of work that goes on behind the scenes. With 100 acres of land and kilometers of fencing and water lines, a team of dedicated individuals work hard ensuring it all works and is safe for our horses and team. Thank you to Brian, Paul, David, Elias, Kevin, and to lan who recently made the decision to leave Canberra and move to the west. This group of individuals along with the farm skills team from Galilee and the Communities work group all help ensure Pegasus is always functioning and looking its best. A special mention also to Marist College and Canberra Girls Grammar for their volunteering throughout the year.

We did, however, *Partner* with the IMB Community Bank Foundation who generously granted \$8,000 to help create new communication strategies and tools for our coaches and volunteers. With many of our participants being nonverbal it is important our team have the correct tools and training to ensure inclusion for all. This has included the printing of visual cues that are in line with what many families and schools already use, along with training being provided to our team members on how to use these symbols. This has included evening training sessions and regular video posts to our Facebook pages.

Another regular supporter for Pegasus is the Eldon and Anne Foote Foundation who this year provided \$15,000 towards the purchase of new horses for our herd. Although we do receive generous donations and long-term leases for some of our herd, we are also required to purchase horses at market rates. This is a big cost to Pegasus and the support from foundations such as Eldon and Anne Foote help reduce that burden.

Thank you to the above foundations for your support this year.

So, as we say farewell to the year that was, I take this opportunity to thank all of the team that makes every day possible. To Chai, Jo, Kirsten, Maple, Sam and Nicola who keep the wheels turning, the donations coming in and the volunteers and horses busy; to our coaches past and present - Andrew, Brooke, Cathy, Chris, Janelle, John, Lynne, Margo, and Yolanda for delivering quality classes as we came to the end of a difficult three years.

And of course, the board who have helped **Govern** and support me as we deliver our new strategic plan. A special thank you to Kellie for taking on the role of Acting CEO back in May while I was on a month-long holiday, allowing me the opportunity to clear my head and spend valuable time with my family.

As you read this report we are well and truly along the path of our next journey, and I can't wait to share those successes with you over the next 12 months.

It's always hard to believe that another financial year has gone by. In my role at Pegasus, I have the pleasure of meeting and working with some of the most generous people in our community. Over the financial year Pegasus received over \$10,000.00 through the sale of sausages and drinks.

Pegasus are very pleased to be selected as part of the Community Rewards Program SCCC which allows members to nominate a charity where 7.5 cents in each dollar is donated. 


