PRESIDENT'S MESSAGE

Wendy Gould



I am pleased to present this year's Annual Report of Pegasus' 49th year of operation – just one year out from our 50th Anniversary year.

We are now two years into our five year Strategy and I'm pleased to report positive progress against all five pillars – Engage, Partner, Grow, Celebrate and Govern. Not only have these pillars guided our focus and direction, but they have also helped us to focus our communications and reporting, providing a simple but effective foundation for all that we do at Pegasus. Many Strategies are left on the shelf, only to be dusted off once each year, but the Pegasus Strategy, because of its simplicity, is brought to life every day through our interactions and our actions against these pillars.

This year, Pegasus delivered over 600 sessions to 78 participants, across all our programs and, once again, this would not have been possible without the generous support of the Pegasus community, staff, volunteers, donors, and sponsors alike. We, again, benefitted from a variety of fundraising activities throughout the year which boosted our financial position considerably. This support is critical to our ongoing operation, and we value the contributions of all of our donors and sponsors as, without them, we could not continue. Details of these activities are provided in our financial statements, however, to summarise, we received in total \$643,302 up 15% from last year, in donor support across the year.

Support via a grant from ACT Sport & Recreation has continued with \$48,971 (as of June 30) of a total grant of \$225,000 over three years being expended to date on expanding our coaching capability and our equine-based programs. Through our engagement activities, we have been able to establish new partnerships through the year, including most notably, partnerships with Equine Pathways Australia and Horses Helping Humans. Both partnerships have enabled Pegasus to expand our offerings and provide pathways beyond Pegasus for

some of our participants. Our partnership with Horses Helping Humans has seen a number of new Equine Assisted Learning coaches, assistant coaches and volunteers trained and qualified, with our pilot program set to commence during Term 4 of this year. This program will run in parallel with our core RDA activities and will be important in ensuring the long term sustainability of our programs and our herd. This will also ensure we continue to offer relevant programs to more members of the wider Canberra community. Our mounted RDA programs continue with our existing professional RDA coaches and we are pleased to welcome Mary Webb back to Pegasus to lead our Saturday programs. Louise and Rose have continued to progress their coaching qualifications and have competed their level 0 and are well into their Level 1 qualifications; and our newest coach trainee, Lisa, has started on her RDA coach journey.

We have seen positives changes in our herd through the year. This has seen the average age of our herd drop and allowed us to build two dedicated herds for RDA and HHH, to help deliver quality programs and not over face the workload of our horses across too many disciplines. Our herd is fundamental to the quality of our programs and is a strong focus of the board.

Our Board Directors continue to volunteer their time and energy to support and guide the future direction of Pegasus and I feel privileged to have been able to work with such a professional group of people who are committed to Pegasus' cause. We remain on track with our Strategy and are pleased to see steady improvement in our financials since the removal of government block funding some 8 years ago and the effects of the pandemic. Pegasus' future certainly looks bright.

As always, I would like to recognise and thank our small team who continue to show up every day and go above and beyond to deliver Pegasus' programs. Our donors, sponsors and volunteers also continue to give much of themselves, week after week, to ensure Pegasus continues to operate and, for that, I and the Board offer our sincere thanks and appreciation for every effort.

Thank you to everyone in the Pegasus family for what you do.

FROM THE CEO Matthew Watson

As the current CEO of Pegasus, it is my pleasure to present to you the 2024 Annual Report.

Never standing still, this past year at Pegasus has been one of research and development to take us into the next 50 years.

It is amazing to think

2025 will see us celebrating 50 years since becoming an association and taking on the Pegasus name. To think Pegasus grew from an idea of two locals to become what it has today. Navigating ongoing obstacles over time, including the big change to NDIS that saw our funding cut considerably, the COVID pandemic, and the rise in the need of youth support services, the board and management identified the need to expand.

Several options were considered in how Pegasus can grow programs to offer a broader range of services to the community. After months of review internally and externally we identified Horses Helping Humans TM as the way forward. This program is designed primarily for at risk youth and is delivered through equine assisted learning using natural horsemanship skills. Pegasus is proud to be the first licensee in the area and has already commenced training and pilot sessions, with the full program being launched in 2025.

Alongside this new program, we have also increased our RDA coaching cohort, now with three new volunteers undergoing their coaching qualifications; they have already started to have a positive impact on our programs and community and this will only continue to grow throughout 2025.

Our engagement within the community has also continued to grow and strengthen, through a more dedicated online presence and continuing with our radio coverage with advertising and interviews highlighting Pegasus. We are now seeing and hearing more people talking about the organisation and having a better understanding of what we do. This in turn helps strengthen and legitimise our standing within the community and for our supporters, sponsors, and donors.

This year we held our second annual donor thank you event and our inaugural Mothers Day event, these events helped showcase the flexibility of our spaces and what we have to offer as a venue outside of just horses. Pegasus is a unique venue unlike anything else in Canberra and events such as these are just another way we can help support our primary mission in the development of skills, abilities and confidence in people with disability in the wider Canberra community.

Partnerships have always been important for Pegasus and the past 12 months have been no different, Hayman Partners have

been with is for 5 years, Corkhill Bros continues to support us in several ways, and the Lions Club of Canberra Belconnen has been by our side for 10 years now. The most notable highlight in 2024 has been with Capital Chemist, a long time adoptee of horses, scholarships and events, this year Capital Chemist signed on to be our uniform sponsor for the next three years, allowing all of our volunteers to have access to matching shirts and in 2025 we will be working towards a uniform for all our participants. It has been wonderful seeing the team matching and adds to the sense of community. Thank you to everyone who supports Pegasus, be it financially or in kind, we wouldn't be the organisation we are today without this support.

In recognition of the amazing support of our volunteers we held our first trivia night and awards event, traditionally held as part of the Christmas event over the past years, in 2023 we decided to separate the events again and added the trivia for some fun. Congratulations to all the volunteers who took away an award on the night, and a special congratulations to Rose who not only won Pegasus Young Volunteer of the Year, but also won RDA Australia's National Young Volunteer of the Year award. We cannot overstate how much our volunteers do for Pegasus and that their contribution is what keeps us going. From myself personally, thank you to everyone of our volunteers.

Our Galilee farm skills program continued for its third year seeing students attending Pegasus every Friday, developing hands-on skills by working on the farm. With over 100acres of land it is important to recognize the work that is needed to keep the property functioning. Thank you also to Brian (since retired), David, Elias, and Paul who have put it countless hours on the land. Also, to Marist College who regularly volunteer time on a fortnightly basis in the gardens and other projects around Pegasus.

Pegasus is truly a local Canberra organisation, not only delivering programs to those in need within our community but bringing the community together though volunteering, all funds raised stay with Pegasus and the services we deliver support locals. We should all be very proud of this and not lose this vision.

I take this opportunity to say thank you to my amazing team who work tirelessly, do so much with at times the very basics. Chai, Jo, Kirsten, Maple, Nicola and Sam, who keep the wheels in motion, the funds coming in and the programs running; and to our coaches John, Chris, Margo, Lynne, Louise, Rose, Yolanda (since moved away), and Brooke (since moved away) for delivering quality sessions every week; and again our amazing cohort of volunteers who give so generously of their time.

Finally, thank you to the board for their continued support in my role as we look towards our 50th celebrations next year, new HHH programs and continued growth in our existing RDA programs.

2025 is going to be another big year and I look forward to working closely with you all to make it happen.



Report on the Financial Report

Opinion

We have audited the accompanying financial report of Riding for the Disabled of the ACT Incorporated (the Association), which comprises the statement of financial position as at 30 June 2024, the statement of profit or loss and other comprehensive income, statement of changes in equity and statement of cash flows for the year then ended, and notes to the financial statements including a summary of significant accounting policies, and the members' declaration.
